4. **Public Forum**- *(State law prohibits the City Council from considering or deliberations on any item not listed on the posted City Council Agenda. A person may address the Council on items on the printed Agenda and not on the printed Agenda. Comments are limited to three (3) minutes. The Council may not comment or deliberate regarding such statements or comments during this period. Any discussion of the subjects must be limited to a proposal to place the subject on the agenda for a future meeting. Sec. 551.042 of Open Meetings Act).*
5. **DISCUSS** (no action) on Investment of Uncommitted Reserve Funds.
6. Discuss/Consider/Act on the designation of streets to be rebuilt or repaired and the commitment of funds.
7. Discuss/Consider/Act on the sale of surplus or obsolete or badly working vehicles or equipment.
8. Discuss/Consider/Act on Approving the Proposed Change in Rate of Oncor Electric Delivery Company, LLC.
9. Discuss/Consider/Act on **DEVELOPING** an Ordinance to prohibit the use metal siding on Residential or Commercial Buildings within the City Limits or ETJ.
10. Discuss/Consider/Act on **DEVELOPING** an Ordinance to require concrete streets with curb & gutter and sidewalks, or other infrastructure construction standards, in new subdivisions.
