3. OPEN PUBLIC HEARING ON THE PROPOSED BUDGET FOR FISCAL YEAR 2024 – 2025.

THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR’S BUDGET BY AN AMOUNT OF \$5,416, WHICH IS A 7.39% PERCENT INCREASE FROM LAST YEAR ’S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$1,624.

THE CITY IS CONSIDERING ADOPTING A PROPOSED TAX RATE FOR TAX YEAR 2024. THE PROPOSED TAX RATE IS \$0.265406 PER \$100 OF VALUE. THE PROPOSED TAX RATE WOULD INCREASE THE TOTAL TAXES IN THE CITY OF DODD CITY BY 5.2%

AN ORDINANCE OF THE CITY OF DODD CITY, TEXAS, ADOPTING THE ANNUAL BUDGET FOR THE ENSUING FISCAL YEAR BEGINNING OCTOBER 1, 2024, AND ENDING SEPTEMBER 30, 2025, IN ACCORDANCE WITH CHAPTER 102, LOCAL GOVERNMENT CODE; APPROPRIATING THE VARIOUS AMOUNTS THEREOF; REPEALING CONFLICTING ORDINANCES AND RESOLUTIONS; INCLUDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

AN ORDINANCE OF THE CITY OF DODD CITY, TEXAS, ADOPTING THE TAX RATE OF \$0.088993 PER \$100 TAXABLE VALUATION FOR OPERATIONS AND MAINTENANCE AND LEVYING A TAX UPON ALL PROPERTY SUBJECT TO TAXATION WITHIN THE CITY OF DODD CITY, TEXAS, FOR THE 2024 TAX YEAR BEGINNING ON JANUARY 1, 2024, AND ENDING ON DECEMBER 31, 2024, FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF DODD CITY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 AND ENDING ON SEPTEMBER 30, 2025; APPORTIONING SAID LEVY AMONG THE VARIOUS FUNDS AND ITEMS FOR WHICH REVENUE MUST BE RAISED; AND ESTABLISHING AN EFFECTIVE DATE.

ORDINANCE NO. 09102024-4

AN ORDINANCE OF THE CITY OF DODD CITY, TEXAS, ADOPTING THE TAX RATE OF \$0.176413 PER \$100 TAXABLE VALUATION TO PAY THE PRINCIPAL AND INTEREST ON THE FUNDED DEBT OF THE CITY AND LEVYING A TAX UPON ALL PROPERTY SUBJECT TO TAXATION WITHIN THE CITY OF DODD CITY, TEXAS, FOR THE 2024 TAX YEAR BEGINNING ON JANUARY 1, 2024, AND ENDING ON DECEMBER 31, 2024; APPORTIONING SAID LEVY AMONG THE VARIOUS FUNDS AND ITEMS FOR WHICH REVENUE MUST BE RAISED INCLUDING PROVIDING A SINKING FUND FOR THE RETIREMENT OF THE BONDED DEBT OF THE CITY; AND ESTABLISHING AN EFFECTIVE DATE.
